**RESTATED CERTIFICATE OF INCORPORATION
OF
BESTSELF BEHAVIORAL HEALTH, INC.**

Under Section 805 of the Not-for-Profit Corporation Law

1. The name of the corporation is BestSelf Behavioral Health, Inc. (the “Corporation”). The name under which the Corporation was formed is Mental Health Services-Erie County Lake Shore Corporation VI.
2. The Certificate of Incorporation of the Corporation was filed with the Secretary of State on December 27, 1972.
3. The text of the Certificate of Incorporation of the Corporation as amended and changed heretofore is hereby restated without further amendment to read as herein set forth in full:

**CERTIFICATE OF INCORPORATION
OF
BESTSELF BEHAVIORAL HEALTH, INC.**

Under Section 402 of the Not-for-Profit Corporation Law

1. The name of the corporation is **BestSelf Behavioral Health, Inc.** (the “Corporation”). The Corporation is a charitable corporation as defined in subparagraphs (a)(3-a) and (a)(5) of Section 102 of the Not-for-Profit Corporation Law.
2. The purposes for which the Corporation is formed are:
 - (a) To establish, own, operate and maintain outpatient facilities for the examination, diagnosis, care, treatment, rehabilitation, or training of adults and children with mental illness, substance abuse problems or alcohol abuse problems and the families of such persons.
 - (b) To maintain a clinic for the study and treatment, without profit to the Corporation, of emotional problems of adults and children referred to it by agencies which have been approved by the Corporation’s board of directors.
 - (c) To operate chemical dependence, alcoholism and/or substance abuse services, within the meaning of Articles 19 and 32 of the Mental Hygiene Law and the Rules and Regulations adopted pursuant thereto as each may be amended from time to time, which shall require as a condition precedent before engaging in the conduct of any such services an Operating Certificate from the New York State Office of Alcoholism and Substance Abuse Services.

(d) To establish, operate, and maintain programs for the mentally disabled pursuant to Article 31 of the Mental Hygiene Law, subject to the issuance of an operating certificate by the Office of Mental Health. The Corporation may not establish any facility or program without first obtaining such operating certificate.

(e) To provide human services to adults and children, including, without limitation, services related to treatment and amelioration of mental illness, mental retardation, substance abuse, and other mental disabilities; provided, however, that the Corporation shall not establish a community mental health facility or a mental retardation facility, or carry on any of the activities described in Sections 404 (a), (b) – (p) , 404 (r) – (t), or 404 (v) of the Not-for-Profit Corporation Law, except that the Corporation shall be authorized to operate one or more outpatient facilities for persons with mental disabilities.

(f) To contract with agencies existing from time to time, governmental departments, family services, societies, nursing homes, and any other organizations engaged in providing, encouraging, and fostering the delivery of human services connected with mental illness, mental retardation, substance abuse, and other mental disabilities; to arrange for the provisions and/or coordination of services and facilities related to mental illness, mental retardation, substance abuse, and other mental disability; provided, however, that the Corporation may contract with any organization or organizations if the services provided by such organizations are reasonably related to the needs of the population served by the Corporation.

(g) To acquire by grant, gift, purchase, devise, or bequest, and to hold and dispose of such property, both real and personal, as the purposes of the Corporation shall require, subject to such limitations as may be prescribed by law, in furtherance of its purposes and not for pecuniary profit.

(h) (i) To own, construct, develop and operate housing facilities for homeless persons with disabilities.

(ii) To buy, own, sell, assign, mortgage, or lease any interest in real estate and personal property and to construct, maintain and operate improvements thereon necessary or incident to the accomplishment of the purposes set forth in Article 2 herein.

(iii) To do and perform all acts reasonably necessary to accomplish the purposes of the Corporation, including the execution of a Regulatory Agreement with the Secretary of Housing and Urban

Development, and of such other instruments and undertakings as may be necessary to enable the Corporation to secure the benefits of capital advances or project rental assistance. Such Regulatory Agreement and other instruments and undertaking shall remain binding upon the Corporation, its successors and assigns, so long as a mortgage on the Corporation's property is held by the Secretary of Housing and Urban Development.

(i) The Corporation shall be organized and operated in such manner that no party of its net earnings shall inure to the benefit of any member or private individual, and shall not carry on propaganda or otherwise attempt to influence legislation, and further, shall not participate or intervene in (including the publishing and distribution of statements) any political campaign on behalf of any candidate for public office.

(j) Notwithstanding any of the provisions of this Certificate, the Corporation is organized exclusively for charitable, educational, religious, or scientific purposes, as specified in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended. Upon dissolution of the Corporation, its assets will be distributed to the Erie County Department of Mental Health, the unit of local government, or shall be distributed by a court of competent jurisdiction to another organization to be used in such manner as in the judgment of the court will best accomplish the general purposes for which the corporation is organized.

3. The number of directors shall be not less than eleven (11) nor more than twenty one (21).

4. The Corporation is a Type B corporation. The office of the Corporation is to be located in the City of Buffalo, County of Erie. The Corporation's activities shall be carried on exclusively in the County of Erie.
